I / We _____ agree to pay Eastern Fleurieu R-12 School Governing Council Incorporated the sum of \$1200.00 to lease a school laptop as part of the school's laptop program in accordance with the following terms:

1. I / we understand and agree to the responsibilities outlined in the 2026 School Supplied Laptop Information letter
2. I / we will pay \$400 per year for a period of three (3) years, commencing in 2026
3. I / we will pay an instalment of \$_____ every week / fortnight / month
4. I / we agree that the first instalment will be paid no later than 4:00p.m. on ____/____/2026 (Date)
5. I / we agree that every following instalment will be paid no later than 4:00 p.m. weekly / fortnightly / monthly from the date stated in Paragraph 3, until the full amount of the debt (\$400) is paid for 2026
6. I / we agree to recommence payments at the above specified amount and frequency on ____/____/2027 (Date) until the full amount of the debt (\$400) is paid for 2027
7. I / we agree to recommence payments at the above specified amount and frequency on ____/____/2028 (Date) until the full amount of the debt (\$400) is paid for 2028
8. I / we understand that should two instalments be not paid on time, the Governing Council may, without any further notice, cancel this agreement and undertake legal proceedings to recover the sum outstanding
9. I / we agree to notify the school immediately if I / we change my / our address or telephone number. I / we understand that, if I / we do not notify the school of such a change, the school may, without any further notice cancel this agreement and commence legal action for recovery of the amount outstanding.
10. I / we acknowledge that the laptop remains the property of Eastern Fleurieu School until the end of the 3 year lease period.

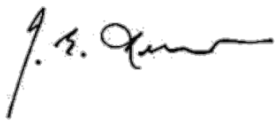
